**MOTION FOR AWARD OF ATTORNEY’S FEES AND EXPENSES TO CLASS  
COUNSEL**

Pursuant to Fed. R. Civ. P. 23(h) and 54(d)(2) and ¶ 21(c)(i) of the Settlement Agreement in this case, ECF No. 73-1, Plaintiff Paul Moore (“Representative Plaintiff”) respectfully requests approval an award of attorney’s fees equal to one-third of the \$1.8 million Common Settlement Fund created by the Settlement Agreement, plus reimbursement of a portion of Class Counsel’s litigation costs in the amount of \$8,100.00.

This Motion is well within the benchmark applied in similar cases, especially considering the results of this case. Additional grounds and authorities for this Motion are in the accompanying memorandum of law, which is incorporated.

WHEREFORE, Representative Plaintiff respectfully requests that the Court approve an award of attorney’s fees of one-third of the \$1.8 million Common Settlement Fund, plus reimbursement from the Common Settlement Fund of a portion of Class Counsel’s litigation expenses in the amount of \$8,100, and enter the comprehensive proposed Final Order Approving Settlement and Certifying Settlement Class submitted with the Motion for Final Settlement Approval.
